• Regardless of how the Investigational Grab Sampling Program is funded and who does the sampling, E. coli grab sample data will be provided to GLWA to store and make available through the Watershed Hub datamart/GIS mapper.

ACTION ITEMS:

- USGS will look into adding carbonaceous biochemical oxygen demand (CBOD) and microbial source tracking (MST) as parameters to analyze as part of the Regional Water Quality Monitoring Program.
- USGS will add a column to the Regional Water Quality Monitoring Program site spreadsheet to note whether the location is already a site.
- Annette, Jeff/Stacey, and Joel/Lynn will each prioritize their recommended Regional Water Quality Monitoring Program Phase 2 sites.
- Brittany will add to a future agenda discussion of Regional Water Quality Monitoring Program Phase 2 site locations and parameters to be analyzed at each.
- Annette and Noel will meet with Patrick Cullen, Wayne County, to determine how to address gaps in Wayne County, should Oakland and Macomb Counties prefer to implement the Investigational Grab Sampling Program independently.
- Annette will reach out to the Western Townships Utility Authority (WTUA) to gauge interest in the Investigational Grab Sampling Program.
