FY 2023 Budget Summary

Exhibit 1 provides a summary of the total FY 2023 budget allocations, including reallocation dollars for Detroit and Flint. Data for Detroit are not included in the remainder of the quarterly report because the Detroit Water and Sewerage Department implemented a water affordability program for Detroit households called the Lifeline Plan. GLWA and PSC are currently evaluating Lifeline Plan data collected and reported by Wayne Metro and will report Lifeline Plan outcomes in a separate report.

Total Funding

Flint spent \$176,677 of its total amount allocated, including for direct assistance, conservation, and administration (Exhibit 2). Oakland County spent \$69,163 of its total allocation, while Out Wayne spent \$214,599.

Based on the total amount of funds spent in Q1 at the time of reporting and the total amount allocated for FY 2023, Flint has approximately \$1.4 million remaining, while Oakland has just over \$1 million remaining (Exhibit 3).



Macomb has spent 27 percent of their total amount allocated and Out Wayne has spent 20 percent (Exhibit 4).



Direct Assistance

More than 300 households (327) enrolled in WRAP in Q1 were in Macomb County, while 234 were in Out Wayne (Exhibit 5). In Oakland County, 174 households were enrolled and in Flint, 81 were enrolled.


EXHIBIT 5. Number of Households Enrolled by Program Year

The largest number of households were enrolled in July 2022 (210 households), followed by August 2022 (192 households) and September 2022 (164 households) (Exhibit 6).

EXHIBIT 6. Number of Households Enrolled by Month



At the end of Q1, \$114,886 direct assistance dollars were committed in Flint, out of just over \$1 million dollars allocated for direct assistance, while Oakland County has committed \$65,307 (Exhibit 7). Washtenaw, Lapeer, Monroe, and St. Clair Counties have not committed any of their allocated direct assistance dollars.

Based on the direct assistance dollars committed and the amount allocated at the time of reporting, Flint has \$969,761 remaining, and Oakland County has almost \$753,359 remaining (Exhibit 8).



Macomb has committed 20 percent of their total allocated funds, while Out Wayne has committed 14 percent (Exhibit 9).

EXHIBIT 9. Percentage of Direct Assistance Dollars Committed of Direct Assistance Amount Allocated





At \$651, Out Wayne had the highest average arrearage balance per household, while Flint had the highest amount of arrearage assistance per household, at \$508 (Exhibit 10). Arrearage balances at the time of enrollment were not reported for Oakland County or Flint.

EXHIBIT 10. Average Arrearage Balance and Arrearages Paid per Household





Conservation and Minor Plumbing Repairs

The largest number of households enrolled in conservation was in August 2022 (108 households), followed by July 2022 (78 households) and September 2022 (42 households) (Exhibit 11). A total of 228 households were enrolled in conservation in Q1.


EXHIBIT 11. Number of Households Enrolled in Conservation by Month

At the end of Q1, Flint has paid \$74,288 out of its \$271,162 allocated (Exhibit 12). Lapeer, Monroe, and St. Clair Counties have not spent any of their allocated conservation dollars.

Based on the conservation dollars paid and the amount allocated at the time of reporting, Flint has \$196,874 remaining while Oakland has almost \$200,000 remaining (Exhibit 13).



Macomb County had the highest average amount of plumbing repairs per household at \$945, followed by Out Wayne at \$867 (Exhibit 14). Lapeer, Monroe, and St. Clair Counties did not conduct any plumbing repairs in Q1. Washtenaw reported spending \$825 on plumbing repairs in Q1 but did not report any conservation clients enrolled or home water audits completed in the same time period.

EXHIBIT 14. Average Amount of Plumbing Repairs per Household





Macomb Community Action Agency was the only agency to report the number of water service shut-offs that were avoided at the time of enrollment, which was 46 for Q1 (Exhibit 15).



EXHIBIT 15. Number of Water Service Shut-offs Avoided Enrolled



Community Engagement

Additional Metrics

The performance metrics listed below have been identified as important to track but do not currently have data to support reporting.

- Water conservation: average amount of deemed savings per households enrolled in conservation program
- Household retention: number of households remaining in the program at six months, one year, and completion of second year; number of households removed from the program
- Rapid assistance provided: number of households and average dollar amount awarded
