To Who It May Concern,

The Highland Park Human Rights Coalition has been a strong advocate for clean, safe and affordable drinking water for many years. We respectfully request that the City of Highland Park regain control of its own potable water supply.

The water connection with Great Lakes Water Authority and Highland Park is not safe. For years the residents of Highland Park have endured low water pressure resulting from the emergency water connection forced upon our city. This low water pressure has created an unsafe condition in Highland Park because the system was not designed to be permanently fed through emergency connections. The Highland Park Human Rights Coalition is extremely concerned about the safety and welfare of the citizens of Highland Park.

In addition to the emergency water connections with Great Lakes Water Authority creating an unsafe condition in our city, the Great Lakes Water Authority continues to unfairly burden the City of Highland Park with unaffordable and unreasonable water and sewer rates in violation of court ordered rate settlement agreements.

The emergency water connection between Great Lakes Water Authority and Highland Park is unsafe. Great lakes Water Authority is not cost effective. Residents of Highland Park feel

unheard, taken advantage of and deserve better treatment. The City of Highland Park should regain control of its own potable water supply. Our water plant will provide citizens with affordable water the way it was intended.
