The evaluation team found in the evaluations, oral interviews, and negotiations that the Burns and McDonnell proposal was the most clearly defined, had the best approach, and best team to lead this project. The Burns and McDonnell team consists of highly experienced senior engineers from the Emerson DCS equipment manufacturer and Contractor's familiar with our sites. The evaluation

criteria used for this RFP was based on: Technical Work Plan, Experience and Qualifications, Project Team and Key Individuals, Business Inclusion and Diversity - B.I.D. Economic Equity, and an Oral interview. Cost was not an evaluation factor for this project. The Burnes and McDonnell proposal scored over 31% higher than the next Design-Build Team.

The Burnes and McDonnell proposal cost was slightly lower than the projects budgeted estimated cost of \$7,389,000.00. This fact along with the current economic circumstances related to escalation of material and labor costs led to the evaluation team finding the Burnes and McDonnell cost to be fair and reasonable for a quality proposal.

Provisionary Allowance is an amount included in the Contract Price to reimburse the Contractor for the cost to furnish and perform Work that is uncertain. Any remaining balance upon Final Completion shall be retained by the GLWA and not paid to the Contractor.

Benchmarking was completed by comparing the proposals for this project. This analysis confirmed that rates are in competitive range. The rate comparisons and allowances (if any) are illustrated in the attached cost tabulation.
