Fiscal Year (FY) 2025 Appropriations

- Submitted eight project requests to Senate and House members
- Seven projects are pending approval of final FY 25 Appropriations bills (nearly \$8 million)

2024 Water Resources Development Act Reauthorization

- Submitted five project requests to Rep. Tlaib (nearly \$50 million).
- All five are covered under a new Section 219 "Environmental Infrastructure" authorization created for "Southeast Michigan for \$58 million.
- House passed the final 2024 WRDA bill on December 10. Senate vote is imminent.
- Project funding is subject to annual appropriations.

Outcome of November Elections

- Republicans take control of State House
 - Ending the Dem trifecta in January
- Changes in legislative representation across the GLWA footprint
 - **Rep-Elect Rylee Linting** replacing Rep. Jaime Churches (lost re-election)
 - Rep-Elect Ron Robinson replacing Rep. Nate Shannon (lost re-election)
 - **Rep-Elect Tonya Myers Phillips** replacing Rep. Abraham Aiyash (did not run for re-election)
 - **Rep-Elect Morgan Foreman** replacing Rep. Felicia Brabec (did not run for re-election)



2025 – 2026 Political Outlook

- Changes in House Leadership
 - Republicans: Speaker-Elect Matt Hall and Majority Floor Leader Bryan Posthumus
 - Democrats: Minority Leader Ranjeev Puri and Minority Floor Leader John Fitzgerald
- New committee assignments in House
 - Possibly new committees
 - Will have all new chairs with Republicans
 - Member committee assignments could all change
 - Now changes on the Senate side



GLWA Priorities in Lame Duck

- FY 2025 Supplemental Funding (\$25M)
- GLWA Police Powers (HB 5906, HB 5907, HB 5908, and HB 5909)
 - Passed committee unanimously and full House near unanimous
 - Pending in Senate Local Government Committee
- Public Employer Health Benefit Contributions (HB 6058)
 - Passed committee on party line vote
 - Pending in full House



GLWA Priorities in Lame Duck (continued)

- Water Affordability (SBs 549 554 and HBs 5088 5092)
 - Both House and Senate packages expected to be discharged from committee today and voted out of each chamber
 - Final action expected next week
- Storm Water Utilities (SB 660)
 - Pending in full Senate



What to Expect Next Session? TBD

- Significant dynamic changes with Republicans controlling the State House
- Will learn more about the Governor's and House and Senate Leaders' priorities later this year and early next year
- New committee assignments will be important
- Will evaluate and strategize on opportunities as we have more of this information
