Additional Terms	The previous contract was a two (2) year agreement with one renewal option, versus three (3) years and two (2) renewal options for the new contract.
Additional Products	Products were added to the agreement to comply with additional testing requirements.
Inflation	There was an increase in freight and cost for the items listed in the agreement.
