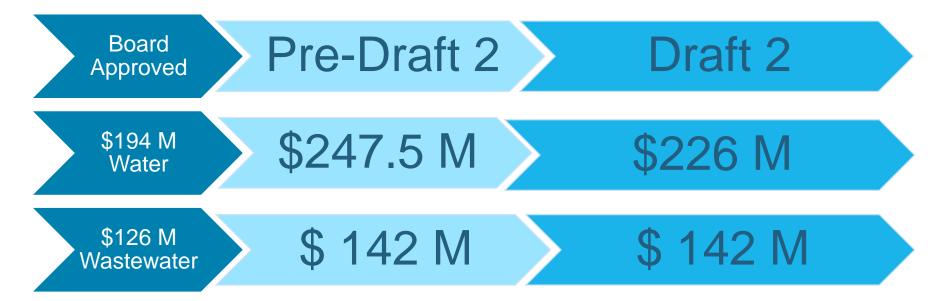

FY 23 Forecast* Re-alignment-Water



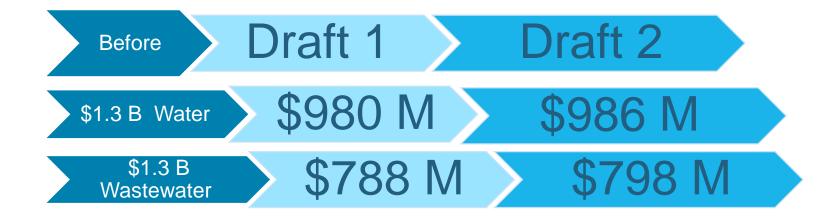

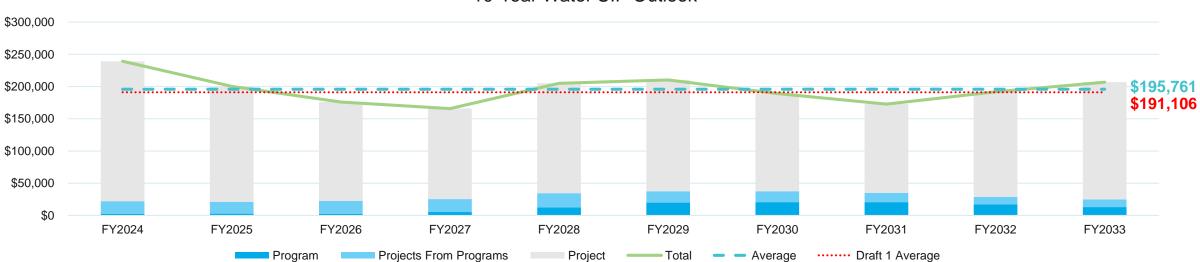

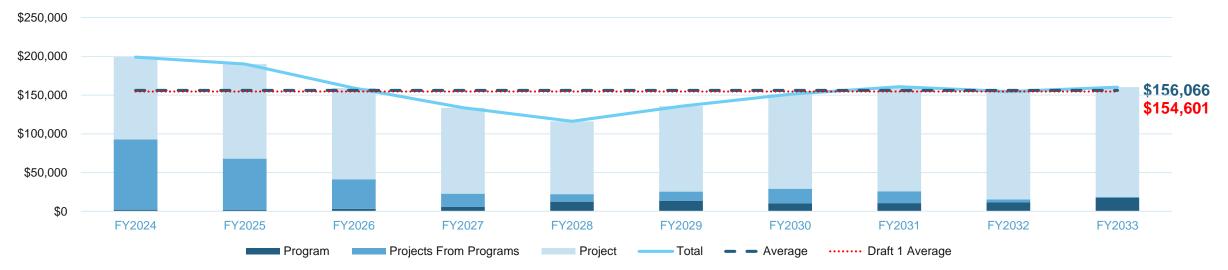

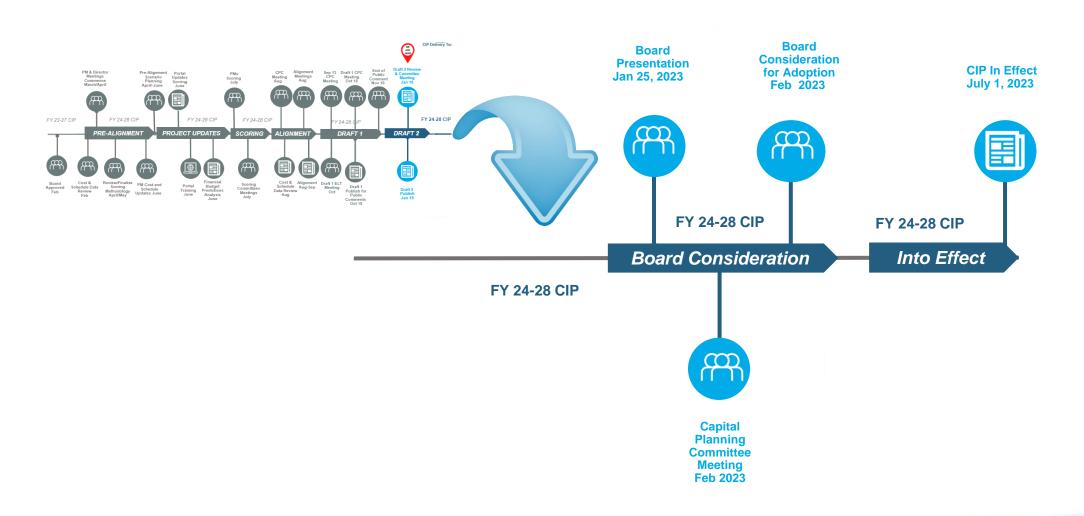
