Re: Update: GLWA and DWSD Shared Services True-Up Status FY 2017 and Beyond

Background: The Great Lakes Water Authority (GLWA) and the Detroit Water and Sewerage Department (DWSD) are parties to a Shared Services Agreement (the Agreement) dated December 1, 2015. This agreement provides the framework for shared services for the efficient operation of both entities.

On a monthly basis, an invoice is prepared based on an agreed upon annual budget. While the intent is for the monthly invoice to represent actual costs, the reality is that the timing of certain vendor invoices and accumulation of internal charges requires a "true-up" process. That being said, the intent is to condense the true-up timeline each fiscal year.

The Shared Service Agreement (Section 5.1) states that:

"Each invoice, whether for Services provided regularly or "as-needed," shall itemize the costs and charges by Services provided under each Service Delivery Schedule, and shall provide sufficient detail to the Subscribing Party to identify the Services performed and the basis for the charges. A Performing Party may only charge the Service Costs for Services provided."

In addition, the parties have come to realize that an exact itemization generates a level of detailed analysis that is not cost-effective to produce. The data and experience garnered from the first three years of the program are leading to a more efficient method of calculating costs while staying true to the intent of Section 5.1 above.

Analysis: The following is an update of the True-Up process by fiscal year.

Fiscal Year 2017 Update

The table below lists the status of each Shared Service based upon GLWA's staff analysis. As of the last meeting on December 18, 2018 between the GLWA and DWSD Shared Services Teams, there was no known issues identified by DWSD with the true-up materials submitted by GLWA for the items identified as "Resolved."

The following list provides additional explanations for FY 2017 Shared Services.

<u>OPS-002 – MISS DIG:</u> Although this service was to be provided by DWSD, DWSD was unable to provide the level of service as stated in the agreement due to a staffing shortage. GLWA provided some of the service to DWSD on an interim basis. The GLWA True-Up has been provided to DWSD and is resolved; the DWSD analysis has been received and is under review by GLWA.

<u>OPS-008 – Systems Control:</u> In the process of completing the FY 2016 True-up for this Shared Service, the details regarding the allocation of facilities and sites was not available. GLWA staff attempted to recreate the allocation based upon best available information and shared the information with DWSD. No consensus was reached and the original allocation in the Shard Services Agreement was used.

There are also costs not identified in the Shared Services Agreement at the time of the bifurcation that need to be considered. The following is the status of these costs.

- o Public Finance In Process

Next Steps FY 2017: As the True-Ups are completed they are provided to DWSD. Meetings are held at least monthly to discuss the status of the completion and resolution of the True-Ups. The next step is a presentation to the leadership for both entities in January 2019 to review the status and to propose cost-effective resolution.
