Sonya brings a deep understanding of procurement and mentorship to this role. Effective immediately, Ms. Collins will also take on the role of Chief Procurement Officer (CPO) as defined by the GLWA Procurement policy. Many thanks to Mr. Daniel Edwards who has served with tremendous dedication as CPO for many months.

The Procurement Pipeline

Today we release the new monthly one-page newsletter *The Procurement Pipeline*. The goals of this communication are to inform the business community about opportunities with GLWA as well as other key updates and topics of interest. Contract Numbers

An element of streamlining business processes is eliminating redundancy and utilizing a key numeric field that is common among all databases. For GLWA, procurements touch a minimum of three databases (WAM, BS&A, and Bonfire). For this reason, the combination of letters in codes used in prior procurements is being replaced with the WAM generated seven-digit requisition number to designate the project and contract number (the first two digits represent the year that the requisition was initiated). The graphic below demonstrates the use the new numbering system (Aeration Decks - 1803188) in contrast

to the prior system (GLWA-CON-238). The new numbers will begin appearing on procurement related Board letters.

Not only does the Policy explain the procurement process, but it also clarifies the roles and responsibilities of GLWA representatives as well as vendors.
