# **Contract Development / Legal Feedback**

- 1. GLWA created 2 new boiler plate contracts, one for Task Order Engineering Services, and one for Job Order Contracting.
  - Each developed required collaboration / input from all areas of GLWA
  - Each took approximately 3-4 months to develop and achieve buyin
- 2. Since execution of contracts:
  - Legal has not heard anything.
  - Reduction in number of contracts Legal Reviews.
