GLWA Government Relations: Federal

- Issues
 - Federal funding
 - Annual Appropriations: WIFIA, SRFs
 - Create new water ratepayer assistance program
 - CARES Act flexibility/new COVID-relief
 - PFAS legislation/federal regulation
 - Federal drinking water standard
 - Federal designation as hazardous under Superfund
 - Water/wastewater utility effluent and solid waste
 - EPA Rulemakings/Updates
 - Lead and Copper Rule
 - CWA Affordability Guidance



GLWA Government Relations: Federal

• Outlook for 117th Congress

- House Democrats retain their majority despite Republican gain. (Smallest House majority in 20 years.)
- Republicans favored to retain narrow Senate majority, pending outcome of two Georgia Special Elections.
- Senate expected to serve as check on Biden
 Administration and Democratic House of Representatives.
- New EPW Committee Chair, Sen. Capito (WV), expected to work on PFAS legislation due to issue in her state.
- EPA will be key to Biden regulatory agenda. (Expect more aggressive action on PFAS regulations.)

2021-2022 Legislative Session Big Picture

- Republican majority 58-52
- Drinking water standards expected to be on both caucus agendas.
- Water affordability funding may be difficult with shrinking state budget.
- PFAS standards will continue to be in the forefront.
