Voter Suppression, Misinformation in Detroit

Vice President Kamala Harris was in downtown Detroit yesterday encouraging people to get protected from COVID-19 by getting vaccinated. Less than 40% of Detroiters are vaccinated. Harris also held a "listening session on voting rights" and spoke about the nationwide assaults on voting rights and voter suppression efforts by the Republican Party designed to drive down and prevent voters from exercising their right to vote. The Republicans are proposing 39 pieces of legislation that will, restrict ballot drop box usage, reduce hours, eliminate sending automatic absentee ballot applications, and eliminate postage paid return ballot envelopes, among other things.

One glaring omission is that the Detroit Election Commission under the direction of the Detroit City Clerk, a Democrat, is suppressing the vote in certain sections of the city by eliminating Satellite Vote Centers, eliminating ballot drop boxes and disseminating incorrect voter registration information. The Clerk is planning a 14 - 20% voter turnout for the August 3, 2021 Primary Election and doesn't want to spend the taxpayers money to fully staff the election. This is voter suppression! "Let's get real about what's going on in Detroit" said Beverly Kindle-Walker, candidate for Detroit City Clerk.
