Cinday Darrah addressed Directors Brown and Hendrix, representatives for the City of Detroit, regarding a reduction in rates for City of Detroit residents.

Michelle George addressed the Board regarding rate increases for the City of Detroit residents.

Saulius Simoliunas addressed the Board regarding Great Lakes Water Authority debt.

JoAnn Warwick addressed the Board regarding concerns relating to contaminates leaking into the water system by demolition sites, and the notification process when there is a problem with the water.

Chairman Baker asked if there was anyone else in the audience that would like to make comments.

There were no further comments by the audience, however, Director Brown responded to public comments made regarding rate increases and contaminates leaking into the water system.

Director Brown stated that prior to the Great Lakes Water Authority being established in January 2016, DWSD saw double digit rate increases for 20 straight years; one year it was as high as 17%, and our rates are now capped by 4% of revenue, and DWSD has not increased rates any higher than 4% for the last two years, and DWSD is being very diligent about keeping rates as low as possible.

Director Brown also responded to the comments made regarding the demolition issues and contaminated soil and stated that DWSD does not have a well system, it has enclosed pipes, so there is little to no chance that any dirt that is contaminated could seep into our system.

There being no further public comments, Chairman Baker adjourned today's Public Hearings at 2:50 p.m. and advised the public that if the Budget, Charges

and Capital Improvement Plan are not approved today, the Public Hearings will remain open, and members of the public may submit written comments until such time as the Budget, Charges and Capital Improvement Plan are approved by the Board of Directors.
