Counsel, the Board of Directors for the Great Lakes Water Authority (GLWA): (1) approves an Easement Agreement between GLWA and the Charter Township of Shelby, the property owner of Shelby Township Parkland East Side of Dequindre Road, Shelby Township, Michigan 48317 (Part of Tax Parcel No. 23-07-19-100-013), including the execution of an Easement Agreement; and (2) authorizes the Chief Executive Officer to take such other action as may be necessary to accomplish the intent of this vote.

#### **JUSTIFICATION**

GLWA must acquire a temporary easement over property owned by the Charter Township of Shelby. The easement is needed in conjunction with the 96-inch water main relocation project. Without an easement agreement, GLWA cannot move forward with the 96-inch water main relocation project in the most cost-effective manner.

#### **BUDGET IMPACT**

Easement acquisitions were included in the budget for the 96-inch relocation project.
