#### MOTION

Upon recommendation and opinion of Randal M. Brown, General Counsel, the Legal Committee recommends to the Board of Directors (Board) for the Great Lakes Water Authority (GLWA):

- GLWA v. Storage Operations LLC, et al.; 18-006896-CC consistent with an attorney-client communication; and
- 2) To authorize the Chief Executive Officer to take such other action as may be necessary to accomplish the intent of this vote.

## **JUSTIFICATION**

These easements are needed by Wastewater Operations to complete the Water Resource Recovery Facility's Third Electrical Feed. Through a facilitation, a settlement of \$460,481.34 in additional money, inclusive of interest, attorney fees and expert's fees, was reached. Through the condemnation process, GLWA made good faith offers on the subject easements and already paid \$214,930.00 to the property owners. The settlement is subject to full Board approval.

#### **BUDGET IMPACT**

These condemnation actions were anticipated in Wastewater Operations Budget.

#### **COMMITTEE REVIEW**

This matter is being presented to the Legal Committee at its July 22, 2020 Meeting. The Legal Committee unanimously recommended that the GLWA Board adopt the resolution as presented.
