The purchase requires specialized equipment. The Secondary Clarifier System includes 50 flow meters originally manufactured by Endress + Hauser. Beginning about 2014, the electronic component was no longer manufactured by Endress + Hauser. For that reason, the WRRF looked for a different meter manufacturer. Since that time, the WRRF has purchased nine (9) Krohne meters, and they have performed up to expectations. To provide continuity of service, simplify spare parts, maintenance, and communication, we will continue to purchase from Krohne.
